**Monthly Swimming Fees from 1<sup>st</sup> October 2020.**

Swimming fees are payable on the 1st of the month throughout the year (they are divided equally over 12 months) through Team Unify by Debit or Credit Card payment.

The monthly fee comprises of two elements. The first covers all aspects of Club Membership and the second is a Training Fee which varies depending on squad. This Training Fee reflects the pool and gym time offered to each squad and the level of teaching/coaching offered.

\*Due to pool availability issues we are adopting a 1 or 2 lessons a week approach at West Hill Park for Learn to Swim stages 4-7. Stages 1-3 are not affected and will continue to have 2 lessons a week at Fareham Leisure Centre.

By joining the club, you agree to pay the monthly fees for the relevant squad. Fees will be payable on the 1<sup>st</sup> of the month. Members starting within the first week of a month will be charged for this initial month. Members starting thereafter in the initial month will be charged a reduced training fee.

A member wishing to resign membership of the Club must give to the Secretary **written notice** (email is sufficient) of his/her resignation, **one month in advance** please to allow the club time to fill the swimmers place.

**N.B.** Non-payment of monies owed to the club may result in the swimmer NOT being allowed to swim until debts are cleared.
